REMINDERS

STUDENT-ATHLETE EMPLOYMENT
SUMMER JOBS

- Student-athletes must be:
 - Paid only for work actually and already performed
 - Paid at the going rate
 - Not paid or hired because of athletics reputation
- All student-athletes should complete the ACS Student-Athlete Employment form.

STUDENT-ATHLETE EMPLOYMENT
LESSONS


- Student-athletes cannot:
 - Use their name, picture, or appearance to promote or advertise the lessons, or
 - Use ASU facilities.
- Compensation must be from the person receiving the lesson or the recipient's parents.
- Compliance Office must have:
 - Documentation of the payment/recipient, and
 - The fee charged for the lesson.

SUMMER WORKOUTS
VOLUNTARY WORKOUTS

- Allowed during the summer vacation period, which begins May 7, 2017.
- Voluntary activities:
 - May not be observed, supervised, or directed by coaches or sport-specific noncoaching staff members;
 - Attendance may not be recorded and information related to the activity may not be reported to coaches/staff;
 - Student-athletes must initiate the requests; and
 - There is no penalty for missing and no recognition or incentive for attending.

SUMMER WORKOUTS
CONDITIONING – STUDENT-ATHLETES

Strength and conditioning coaches may design and conduct student-athlete workouts, if:

- The workouts are voluntary, and
- No other coaches or sport-specific staff members are present.

SUMMER WORKOUTS
CONDITIONING - PROSPECTS

In addition to the requirements of student-athletes, and before participating, prospects must:

- Undergo a medical evaluation within the previous six months (including sickle cell);
- Have signed an NLI (or paid financial deposit)*; and
- Receive Compliance Office clearance.


*New rule from last summer: Prospects no longer have to be enrolled in classes.

 **SUMMER WORKOUTS**
COACH PRESENCE: INDIVIDUAL SPORTS


- A coach may participate in a workout session if the workout is:
 - With a returning student-athlete (not a prospect) who initiates the request, and
 - During the summer vacation period.
- Workouts may involve multiple student-athletes.

 **SUMMER WORKOUTS**
COACH PRESENCE: SAFETY EXCEPTION


- Workouts are initiated by the student-athletes and attendance is not recorded.
- Coach cannot conduct the workouts.
- Only safety instruction can be provided.

COUNCIL PROPOSALS
WGY AND MWR

New proposal passed:

- A prospect (and relatives) may not take unofficial visits before September 1 at the beginning of the prospects junior year.
- Effective date: August 1, 2017

COUNCIL PROPOSALS
WLAX

New proposal passed:

- A prospect (and relatives) may not take unofficial visits before September 1 at the beginning of the prospects junior year.
- A coach/SDA staff member may not receive calls from a prospect before September 1 at the beginning of the prospect's junior year.
- Effective date: Immediate (April 14)

COUNCIL PROPOSALS
ON-CAMPUS CONTACTS – FORMER
STUDENT-ATHLETES

New proposal passed:

- Prospects (and their relatives) may have on-campus contact with former SDA student-athletes.
- Effective date: August 1, 2017

COUNCIL PROPOSALS
UNOFFICIAL VISIT COMMUNICATIONS

New proposal passed:

- SDA staff members may call, text, or email a prospect beginning the day immediately preceding the prospect's unofficial visit through the conclusion of the visit.
- Effective date: August 1, 2017

COUNCIL PROPOSALS
COUNTING EVALUATIONS

New proposal passed:

- Evaluations that occur between September 1 and May 31 count against the permissible number of recruiting opportunities per prospect.
- Evaluations that occur between June 1 and August 31 do not count against the limitations.
- Effective date: Immediate

COUNCIL PROPOSALS
ONE-MILE RADIUS OF CAMPUS

New proposal passed:

- SDA staff members may contact prospects within one mile of campus boundaries during an unofficial visit.
- Effective date: August 1, 2017

COUNCIL PROPOSALS
PHOTOS DURING VISITS

New proposal passed:

- SDA may provide a prospect with the prospect’s photo that was taken during an official or unofficial visit. Size and other restrictions still apply.
- Effective date: August 1, 2017

COUNCIL PROPOSALS
TOURS DURING INSTITUTIONAL CAMPS

New proposal passed:

- Coaches may arrange and conduct tours during institutional camps/clinics as long as the format of the tour has been approved by an institutional authority outside SDA (e.g., admissions).
- Effective date: Immediate

COUNCIL PROPOSALS
SUMMER SCHOOL ATHLETICS AID

New proposal passed:

- To receive summer aid, incoming student-athletes only need to take three-credit hours rather than six.
- Effective date: Immediate
